SPECIAL REQUIREMENTS

- A license for a casino shall not be issued for a period exceeding three consecutive days.
- Casino must finish by 2:00 a.m. Monday through Friday, by midnight on Saturday nights and Sunday casino may not start before 1:30 p.m.
- Information regarding advertising of your lottery scheme can be found in the Lottery Regulations.
- Refer to the Nunavut Texas Hold'Em Poker Tournament Terms and Conditions for further assistance.

GENERAL INFORMATION

- Under the Nunavut Lotteries Act, organizations which are deemed to be charitable or religious and which have charitable or religious objectives or purposes are eligible to hold licensed lottery schemes known as Bingo, Nevada/Pull-tickets, Casino and Raffle, Texas Hold'em lotteries.
- The lottery must be managed and conducted in the manner described in this application, as approved.
- All prizes must be awarded in accordance with the prizes proposed in this application form.
- The proceeds must be used for the charitable or religious objectives specified in the application, as approved.
- Where the total prizes awarded under a series license exceed \$100,000 an audited statement must be submitted.
- Where the prize(s) in a single lottery are to exceed \$30,000., specific approval is required.
- The maximum duration of a license is six months.
